- iii) The M.G.V.C.A.A. Shall have powers to raise loans necessary for any specific purposes coming under its objectives, from any schedule Bank or registered society, etc., subject to such maximum limit as may be resolved upon by its Executive Committee with prior consent of the General Body.
- iv) The funds of the Association shall be deposited in any Schedule Bank / Co-Operative Bank as may be decided upon the Executive committee.

d) Financial year of Association :

The Financial year of Association commence on 1st April and on 31st March of the following Years.

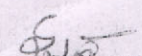
e) Qualification of Members :

Any member of the Association Ignore the rules and regulation of the Association shall be.

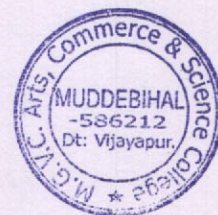

C) LIFE MEMBER :

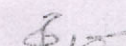
Any Alumuns of M.G.V.C. is entitled to become Life member on payment of a sum of Rs.250/-

- b) All categories of Members except Associate members, once enrolled shall continue to be members for life or until they resing.
- 1) The Executive committee of M.G.V.C.A.A. shall have powers to cancel the Membership of any individual whose behavior and activities are considered injurious to the credit, prputation or interest of the Association, provided that the 2/3 majority of the general body approves such cancellation, if proposed by EC.
- 2) The Association shall maintain an up to date list of all its members in a register kept for the purpose. The said register shall be kept open for inspection by any member during office hours.
- 3) Any alumns of M.G.V.C.A.A. who navs extra along with membership fees the extra amount will be treated as donation & utilized for the benefit of M.G.V.C.

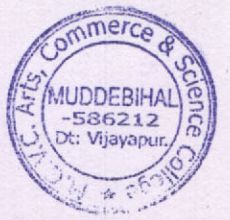

EXECUTIVE COMMITTEE OF M.G.V.C.A.A.



The Association Affairs will be conducted by an Executive duly elected by the General Body of The M.G.V.C.A.A. Comprising the followings.

- i. **PRESIDENT** : The Principle of the College will be the President of M.G.V.C.A.A. if he is an Alumnus of M.G.V.C. if not an Alumnus Senior faculty of M.G.V.C.
- ii. **VICE PRESIDENT** : There shall be two Vice President : External.
- iii. **HON SECRETARY** : There will be one Hon Secretary who will be selected from the serving faculty member and an alumnus and also the member of M.G.V.C.A.A.
- iv. **JION SECRETARY** : External
- v. **HON TREASURETARY** : There will be one Post of Treasurer, He will be one of the serving Faculty member and Alumnus and a member of M.G.V.C.A.A.
- vi. **EXECUTIVE COMMITTEE MEMBER** :
 - a) The General Body will elect 5 Members as Executive Member from the Member of the M.G.V.C.A.A.
 - b) The Executive Committee will Co-opt four members in first meeting after the General Body meeting.
 - c) The Executive Committee shall ordinarily meet at least once in a month and transact the business. All decisions will be taken by a majority of vote. The quorum for the executive committee meeting shall be 8. The notice for the meeting shall be Circulated to the members 7 days in advance along with the Agenda.

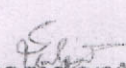
TERM OF OFFICE :

The Term of office of the Executive Committee shall be Three Years.

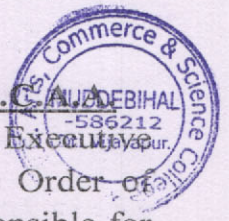
ELECTION :

FUNCTIONS AND POWERS OF OFFICE BEARERS OF M.G.V.C.A.A.



- I) President : The President will preside over all the meeting of the Committee and General. Body He will regulate the debate, the Order of business and give rulings on points raised. The president is Responsible for the overall growth and well being of the Association and shall act the guiding spirit. He shall exercise general control over all the Associations.

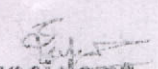
III) Secretaries:

- a) Secretary shall be normally responsible for all the activities of the M.G.V.C.A.A. He shall act as Liason between the Association and Management, arrange for collection of Life Membership Fees arrears, etc, Arrange for proper maintenance of records of all correspondence, liason between Association, Alumni, Governing Council/ Management Committee and such other responsibilities that may be assigned by the E.C. from time to time. He shall issue notices for all meetings and make necessary arrangements, He shall carry out all the decisions of out all the decisions of the General Body and E.C in accordance with the rules.
- b) Joint Secretary shall keep liaisons with the staff Secretary and arrange for the programs of the Association . He shall assist the committee in ats activities including sponsorship Programs, Lecture meeting and shall work jointly with the Secretary in keeping liason with the management, the Alumni and Governing Council/ Management. He shall keep the minutes of the proceedings of the meeting of the general Body and E.C.

- a) He shall keep responsible in preparing a proper receipts for the activities of the M.G.V.C.A.A.
- b) He shall keep proper book of accounts of the receipt sand Expenditure of the Association and the assests and liabilities with proper receipt books and vouchers Association and the assests and liabilities with proper receipt books and vouchers(as per section 122 of the societies Registration Act)
- c) He shall prepare and submit to the E.C. monthly, half yearly and have the annual accounts audited for proper presentation and approval of the accounts in General Body.
- d) He shall keep records and maintain the custody of the assets and liabilities of the M.G.V.C.A.A and present statement to the E.C. and the General Body.

- a) The executive Committee shall approve the Annual Budget and proposal for each action and keep control on the expenses
- b) The Executive Committee by majority vote, shall approve the accounts presented by the Treasurer.
- c) The member of the E.C. Shall approve the appointment of part time / full time staff to assist the officebearers and fix their honorarium.

GENERAL BODY MEETING

- A) Member under all categories except Associate Member, constitute the General Body of the M.G.V.C.A.A.
- B) Annul General Body meeting will be held every year before 31st August, during which the duly audited Annul Accounts will presented by the executive committee for approval. The General body meeting notice will be served to the member's 21 days in advance by the secretary. The business will be transacted as per the circulated Agenda.
- C) Member desirous of moving propositions and resolutions shall send them to the secretary of M.G.V.C.A.A. before 10 days from the date fixed.
- D) Annul General Body Meeting notice, indicated the Agenda and calling for nominations for elections of the years when election are due.

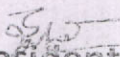
QUORUM

No business shall be transacted at any General / body Meeting unless there is a quorum for the Annual General Body Meeting shall be in accordance under the rules frames under the Societies Registration Act, in the absence of which it shall be one tenth of the total membership or 50, whichever is less. If there be no quorum at any Annual General Body Meeting within half – an – hour of the time fixed for the meeting, the meeting shall be adjourned by another half-an-hour and reconvened to transact the same business even without a quorum.

ACCOUNTS AND AUDIT

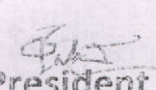
