TRUST DEED, Here in I, Smt. Gangamma w/o Veerappa Chiniwar, Caste-Lingayat, Age-50, occupation. House hold and agriculture R/o. Muddebihal Tal Muddebihal Dist Bijapur today on 9th November 1967 for the welfare and educational development of Lingayat Veerashaiva Samaj herewith I execute this Trust Deed along with my absolutely owned immovable properties are as under.

My heavenly aboded husband late Shri. Veerappa Basappa Chiniwar died on 8th November 1939. Due to wed-lock, no children either male or female were born to me. Even to Shavavva or Shivaleelavva or Adivevva, who were earlier wives to my late husband did not beget either male or female children. They died during the lifetime of my late husband. Circumstance is like that to my late husband Shri. Veerappa, myself is the only legal heir to him. After the demise of my husband, myself is looking after entire movable and immovable properties and as per the Hindu Succession Act 1956 I am the absolute owner of the said properties. After the death of my husband, I am looking after all the movable and immovable properties and I have taken those properties in my personal possession and enjoying the same as an owner. My late husband was very rich (millionaire) from whom I have got the properties which are described at the end of this Trust Deed in the schedule A and B. I am the absolute owner of the said properties which are described in the schedule of this Deed and I am enjoying the same as per my will and wish. In the schedule A the details of the landed properties are described and in schedule B, the details of the house properties are described along with their present market value. My late husband, for the welfare of the society and for the educational development of the Veerashaiva Samaj had not adopted anybody. I have lived my life as the shadow of his life. As a result, his generous and high ideals have been the life breathing of mine. With the determination to tread the way he walked, in order to pray eternal peace to his departed soul, I too have not adopted anyone at present and not willing to adopt anybody in future also. After the death of my husband, in order to fulfill his cherished wish I have donated much of the property inherited from him for the purpose of social prosperity and educational development. I have donated generously big amount to V.B. Chiniwar High School run by Veerashaiva Vidya Vardhak Sangha Muddebihal and many other institutions.

Now I have become aged and the life is uncertain. I don't know when I will join my departed husband. But at present I am totally in good health. To utilize the entire property inherited by me for the noble purposes, and to develop Veerashaiva Samaj which thereby will attain higher excellence, and to enhance educational level of our Veerashaiva Samaj people, with these high ideals, not under the pressure of any body or any circumstances in full cognition and wisdom, I have today made this Trust Deed related to the under mentioned properties in schedules A & B.

With effect from today only I have entrusted through this Trust Deed the ownership and possession of the entire property in schedule A & B to the below mentioned Trustees for utilizing the property for the Trust objectives. Effective from today itself, I do not have any claim or right on the properties mentioned in the schedules. I do not have any right on the said properties either to sell or mortgage or lease out. But I have retained the possession of movable properties in schedules A & B for the purpose of my supervision and maintenance as long as I am alive. After my death, the Trustees are to take possession and ownership of the properties mentioned in the schedules A & B and even the movable property that belongs to me today. All these properties are to be utilized for attaining the objectives written below. Even during the period I am alive, if the Trustees resolve by majority, without waiting for my due permission, are empowered to sellout part of the Trust property as per the legal provisions, and as a Chairman of the Trust I have the power to make the necessary document required for this transaction.

The name of the Trust that is set up through this Deed is:

1. **Shrimati Gangamma Veerappa Chiniwar Vidya Prasarak Trust, Muddebihal**
2. **The main administrative office of the Trust is to be situated at Muddebihal only.**
3. **The aims and objectives of the Trust are as follows:**
 - a) To start educational institutions and equivalent institutions, to manage these institutions in suitable way so that the objects of such institutions shall be successfully fulfilled.
 - b) To provide scholarships, freeships and encouragive prizes and awards in the form of cash to the meritorious and poor Veerashaiva students.
 - c) To provide interest free loans to the students belonging to Veerashaiva Samaj who pursue their higher education in India or in foreign countries.
 - d) To run free-boardings for the benefit of poor students.
 - e) To set-up Libraries and Reading Rooms on behalf of the Trust and manage them property.

The Trust property and the money are to be utilized for the above stated objects of the Trust and not for any other purposes.

To purchase the necessary lands for the purpose of executing the objects of the Trust, to construct the buildings for the educational institutions run by the Trust, to construct hostels, to setup free-boardings to construct the buildings for libraries, to procure the books required for the library, are the purposes which comprise in the scope of the objects of the Trust.

4. The following comprise the property and resources of the Trust:

- a) All the properties that I have donated to the Trust as shown in the schedules (A) & (B).
- b) All the donations, gifts and other endowments that will be given by the individuals and institutions to the Trust in future.
- c) The financial assistance that will be given by the University Grants Commission.
- d) The fee income and any other income in the form of cash that come from the educational institutions and other related institutions run by the Trust.
- e) Any income that is earned in tune with the objects of the Trust and monetary income received through the sale of the properties of the Trust shown in the schedules, these all will become the assets of the Trust.
- f) All properties of the Trust both movable and immovable, as well as the management and administration of the affairs of the Trust shall vest in the Board of Trustees (Trust Committee) and today onwards itself Board of Trustees will be the owners of all the Trust's properties. And they will responsible in carrying on the affairs of the Trust from today itself subject to the aims and objects of the Trust.

I have nominated the persons to the FIRST Board of Trustees as follows:

1. Shri Shri Shri Sanganasasava Swami Guruchannabasava Swami Shivayogi, Banthanal.
2. Srimati Gangamma w/o Veerappa Chiniwar, Muddebihal.
3. Shrimanth Jagadevrao Sanganasasappa Deshmukh, Naltawad
4. Shri V.V. Jatti, Retired Principal, R.L.S. Institute, Belgaum
5. Shri Dr. Sidaveerappa Revanasiddappa Jigajinni, Bijapur

All these have given their kind consent to be the Trustees of the Trust. These Trustees are my well wishers and will strive for upholding perpetually the honor and ideals of my family. The Trustees nominated now will continue to be the Trustees as long as they are alive. The number of the Trustees will not exceed 5 at any time. In case of any casual vacancy in the post of the Trustees an account of death, resignation or any other reason. I retain the right of nominating a new person as Trustee in my life time. Such casual vacancy will be filled in by majority decision of the Trustees after my death.

I will work as the Chairman as well as the Treasurer of the Trust during my life time and Shri Jagadevrao Sanganasasappa Deshmukh will work as the Secretary.

After my death, the Trustees by majority decision shall elect one as the Chairman of the Trust from amongst them. Such Chairman will also function as the Treasurer during his term as the Chairman. During my life time any post of a Trustee or the Treasurer becomes vacant, I will have the right to fill in that vacant post. After my death, only the person I suggest in writing is to be made the Trustee in my vacant post. If I die without making any suggestion in this way, the Board of Trustees by majority decision will elect to the vacant post. In the event of equality of the votes in such election, the Trustee who presides over this meeting of the Trust Board will exercise his casting vote to have the majority decision. After my death, in case four posts of the Trustees become vacant at a time, the remaining Trustee will nominate suitable persons to these vacancies selected from the Veerashaiva Samaj as Trustees. In the event all the posts of Trustees fall vacant, the Hon'ble Court of Law will nominate suitable persons belonging to Veerashaiva Samaj as the Trustees on the vacant posts and will entrust the responsibility of carrying on the affairs of the Trust.

Any Trustee who is disqualified by law and other reasons will have to be removed from his post and a new suitable person will be nominated to that post by majority decision of the Board of Trustees.

All the management and administration of the Trust vests with its Chairman, but while exercising his power, he is to proceed ahead on the advice and opinion of the Board of the Trust. In case of equal number of votes on any subjects, the Chairman shall have a casting vote.

The Chairman will deposit the Trust money in the account opened in his name and designation in a bank and when the money is withdrawn from the account, the cheque must bear the signatures of both the Chairman and Secretary. Without the signatures of these both officials, the money cannot be withdrawn from the bank account. The Trust can purchase/ subscribe to shares of any institutions or banks. Thus purchased/ subscribed shares must be in the names and designation of the Chairman and Secretary.

To implement the objectives of the Trust, the following additional rights, along with the lawful rights, have been entrusted to it.

As long as I am alive, the Board of Trust must seek my consent while the immovable property mentioned in the Schedule is used or converted for fulfilling the objectives of the Trust. After my death, the Trust Board has got the right to transact the property on the majority decision of the Trust. The money received through the conversion or sale of the Trust properties is to be kept safely in a scheduled bank decided by majority by the Trustees. They should deposit the money in such way that the Trust will not experience any difficulty in carrying on the Trust activities and also they have to see that the money thus deposited and invested earns more income. Henceforth, if the immovable property in the ownership of the Trust is to be sold, more that means, half of the money received

through such transaction is to be used and the remaining half amount is to be safely kept in the form of deposit in the bank. The half of the money is to be utilized for the work of the Trust. i.e. for the construction of the buildings required for the educational institutions run under the Trust and for fulfilling the main aims and objectives of the Trust.

The income that can be received by the Trust from its unsold immovable property, after utilizing it, whatever remains as balance, and the interest income received from the bank deposits and income received from any other sources, all is to be used for the purposes of giving scholarships and awards to meritorious and poor Veerashaiva students: boys and girl students. This right, after I am no more, will rest with the Trust. The Trust can also give interest-free loans to the students going abroad for pursuing higher education. But such loan amount must not exceed Rs. 50,000/- at any time. The Trust has got this right to give scholarship in the form of loan within this limit.

The Board of Trust, for the successful implementation of the aims and objectives as well as for carrying on its activities, has got the right to enter into agreement etc. with any individual, institution and the government. The Board of the Trust for the successful conduct of its affairs and for accomplishing the aims and objectives it is to frame the suitable Bye-Laws. The management of the Trust is to be done as per these Bye-Laws.

The Trust, for successful implementation of its objectives, has the right to appoint the necessary officers and other employees, to decide & entrust the duties and responsibilities of such appointed officers and the employees. So also the Trust has the right to appoint the necessary teachers and other staff required in the educational institutions run by the Trust and to fix the salary to be paid to them.

After the Trust comes into existence, the Secretary of the Trust is to maintain the documents of all the accounts of the Trust and these accounts are to be audited from time to time by the Government official or by the auditor/s decided by the Trust members by majority. In case, for the purpose of successfully accomplishing the objectives of this Trust, if it becomes necessary, the members of the Trust with a majority decision, shall transfer all the assets remaining with it as on that date to any another Veerashaiva Trust or Veerashaiva Institution whose objectives are similar to this Trust and which is a recognized organization under the law.

If the number of Trustees declines to three, the vacant posts should be filled in immediately, by nominating such persons who have the aptitude of conducting the affairs of the Trust with unity and unanimity.

The Board of the Trust and its members, for the purpose of accomplishing successfully the avowed objectives of the Trust, shall be devoting themselves physically and mentally, with full belief in the Trust and God Almighty, will work unitedly, so that the Veerashaiva Samaj attains prosperity progressively, with this

strong desire and by praying God, I have formed this TRUST to which I have given away all the properties mentioned in the schedule A & B

In the back page of the first stamp at 3rd line "Va" number is deleted and '9' number is entered.

In the back page of the second stamp at 22nd line "Gala", this word is deleted and in the fourth stamp's back page at 4th line "Kayi" this word is deleted. In the same stamp back page at 10th line 'Karyagalu' this word is deleted. In this way I have executed this Trust Deed with my own will and wish on the Day of 9th November 1967.

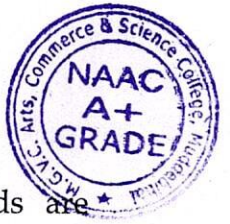
